**918. DISTRICT-WIDE PARENTAL INVOLVEMENT**

The West Mifflin Area School District, in consultation with parents, are encouraged to include other relevant and agreed upon activities and actions as well that will support effective parental involvement and strengthen student academic achievement.

**PART I. GENERAL EXPECTATIONS**

**NOTE:** Each district in its District-Wide Parental Involvement Policy must establish the district's expectations for parental involvement. [Section 1118(a)(2), ESEA]

The West Mifflin Area School District agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.
- Consistent with section 1118, the school district will work with its schools to ensure that the required school-level parental involvement policies meet the requirements of section 1118(b) of the ESEA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESEA.
- The school district will incorporate this district-wide parental involvement policy into its LEA plan developed under section 1112 of the ESEA.

- The school district will involve the parents of children served in Title I, Part A schools in decisions about how the one percent (1%) of Title I, Part A funds reserved for parental involvement is spent, and will ensure that not less than ninety-five percent (95%) of the one percent reserved goes directly to the schools.
- The school district will be governed by the following statutory definition of parental involvement, and expects that its Title I schools will carry out programs, activities and procedures in accordance with this definition:

**Parental involvement** means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring:

- (A) That parents play an integral role in assisting their child's learning.
- (B) That parents are encouraged to be actively involved in their child's education at school.
- (C) That parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child.
- (D) The carrying out of other activities, such as those described in section 1118 of the ESEA for states where a Parental Information and Resource Center is established. The school district will inform parents and parental organizations of the purpose and existence of the Parental Information and Resource Center in the state.

PART II. DESCRIPTION OF HOW DISTRICT WILL IMPLEMENT  
REQUIRED DISTRICT-WIDE PARENTAL INVOLVEMENT  
POLICY COMPONENTS

1. The West Mifflin Area School District will take the following actions to involve parents in the joint development of its district-wide parental involvement plan under section 1112 of the ESEA:

  - a. Direct Building Administrators to actively recruit and involve parent groups and parents of Title I students.
4. The West Mifflin Area School District will coordinate and integrate parental involvement strategies in Part A with parental involvement strategies under the following other programs, such as: Head Start, Reading First, Early Reading First, Even Start, Parents As Teachers, Home Instruction Program for Preschool Youngsters, and state-operated preschool programs, by:
  - a. Alerting parents to district activities and programs via district website and district newsletter.

5. The West Mifflin Area School District will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). The school district will use the findings of the evaluation about its parental involvement policy and activities to design strategies for more effective parental involvement, and to revise, if necessary (and with the involvement of parents) its parental involvement policies.
  - a. The district will conduct an Annual Parent Involvement Evaluation at its May district advisory council meeting. Parents will share an equal role along with educators to evaluate the effectiveness of the parent involvement policy with the goal of improving it's effectiveness. The persons responsible for conducting the evaluations will be the Title I Teachers.
  
6. The West Mifflin Area School District will build the schools' and parent's capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved. parents, and the community to improve student academic achievement, through the following activities specifically described below:
  - a. The school district will, with the assistance of its Title I, Part A schools, provide assistance to parents of children served by the school district or school, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph:
    - The state's academic content standards.
    - The state's student academic achievement standards.
    - The state and local academic assessments including alternate assessments.
    - The requirements of Part A.
    - How to monitor their child's progress.

- How to work with educators:
  - 1) The West Mifflin Area School District and the Allegheny Intermediate Unit provide opportunities for parents to participate in workshops such as PSSA Testing and No Child Left Behind. Most of these workshops can also be accessed through Internet websites.
- b. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:
  - 1) Providing reading materials and supplies as well as How-To Workshops which focus on the parents role in supporting this child.
- c. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
  - 1) Specifically providing discussion time and printed materials (the Master Teacher) to staff members.
- d. The school district will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start; Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program; and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
  - 1) Supporting and attending Allegheny Intermediate Unit, functions specifically targeting Early Childhood programs.

e. The school district will take the following actions to ensure that information related to the school and parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

- 1) Information is shared with parents of participating students via letters, district website, Cable TV and district newsletters in a language parents can understand.

**PART III. DISCRETIONARY DISTRICT-WIDE PARENTAL INVOLVEMENT POLICY COMPONENTS**
